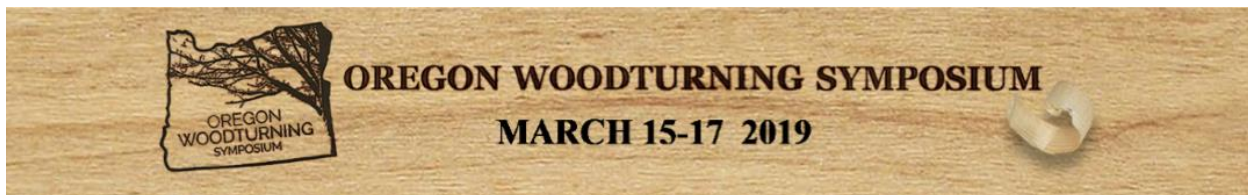
Saturday, March 2<sup>nd</sup> – BOWL TURNING BASICS \$100

## **SAFETY FIRST**

### **It Ain't Worth Dying For A Bit of Pretty**

I confess I once thought fractal, or Lichtenberg, burning was pretty cool. When I was Cascade's president I invited Carl Jacobsen to demonstrate fractal burning at a Cascade meeting. I went to the house of a past president and saw his fractal burning setup. I was intrigued and I began to wonder: should a fractal burner be the next cool tool in my arsenal?



I'm on the AAW safety committee, and right after Carl demonstrated fractal burning for our club the AAW board announced that it would not allow fractal burning to be demonstrated at AAW symposia, to be featured in the *American Woodturner*, or to be shown in AAW-sponsored galleries.

The announcement caught me and a lot of people by surprise. I had some misgivings about the announcement and, in part to help me figure out how I felt about the technique, I volunteered to help draft the article for the *American Woodturner* explaining the board's action.

Interestingly, that article appeared in the same issue as an article about a fellow who uses big, industrial equipment to turn whole tree trunks. That's almost like trying to turn a wooden propeller while it is attached to the airplane and the airplane's engine is running.

I say "interestingly" because the tree-trunk-turning article shows that high risk isn't enough to make the AAW board ban a technique.

Woodturning, in fact, generally has a pretty high potential risk. If you don't believe me, just try to stop a spinning bowl blank with your nose. But the AAW actually encourages people to turn bowls.



Turning tree trunks has a much higher risk. If you try that and mess up, your whole body may get shredded. But the AAW published an article about turning tree trunks.

What makes fractal burning so different that the AAW would ban it, but doesn't ban turning tree trunks? I think two things make it different:

**1. Hardly anybody dies from woodturning, even from turning tree trunks.**

Woodturners get lots of cuts and bruises and the occasional broken bone, but woodturning hardly ever kills them.

Since *June of 2016* newspapers have reported *at least a dozen deaths* caused by fractal burning. One person who died was a man in his thirties with 13 years experience as an electrician. That's *a dozen deaths*, not just instances where people got knocked on their butts.

**2. You can't see what makes fractal burning risky.**

You would have to be pretty dumb to try to stop a spinning bowl blank with your nose, because, if you put your face anywhere reasonably close to a spinning bowl blank you can easily see what will happen if you go closer. And you would have to be flat out crazy to stick your face, arm or other body part into a spinning tree trunk, because a spinning tree trunk practically screams "I want to kill you!"

But you can't see the lethal electricity in a fractal burning setup. The equipment just sits there, looking innocent, until it kills you. The lack of visible danger can lull you into thinking the risk is less than it is, and acting carelessly.

Some people claim that a professionally manufactured fractal burner is safe. It's not. It is likely less risky that making a burner yourself out of parts from old microwaves or neon signs, but being "less risky" isn't enough. That just means you are less likely to die doing it.

All a fractal burning does is create pretty patterns. It just decorates or embellishes. I've decided, for me, that the minor benefit of a bit of pretty decoration isn't worth the major risk of my death. I encourage you to make the same decision.

I'll close with quotes from an article that was published in the St. Clair Shores Sentinel on January 14, 2019:

The St. Clair Shores Police and Fire departments were called at around 3:35 p.m. Jan. 10 to the 23000 block of Allor Street for a report of *a man on fire* in his garage. The Fire Department arrived first and extinguished the flames. When police arrived, officers found a severely burned body in the detached garage of the residence. The man was pronounced dead at the scene.

“He was experimenting with this form of artwork,” said Detective Paul Dlugokenski. “Lichtenberg ... where they pass electricity through wood and it’s supposed to burn. It failed on him and he was electrocuted.”

...[T]he man, who was in his 60s, was discovered by his wife in the unattached garage of the house in the 23000 block of Allor Street at around 3:30 p.m. “**The wife discovered ... smoke coming from the garage. She opened up the garage, and she saw her husband on the floor on fire...**”

‘Nuff said?

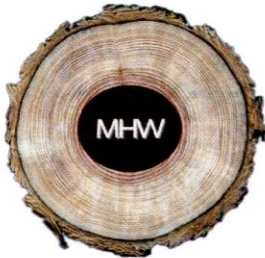
